OTHER FEES

LATE FEE: Payments made after the 15th of the month will incur A \$25 late fee. Payments should be brought to the office or mailed with enough time to arrive on or before the final day of the payment period.

RETURNED CHECK FEE: A \$50 fee is charged for all returned checks.

REFUND OF TUITION: Students leaving FBA during the school year who qualify for a refund will have tuition refunded based on a daily rate times the days enrolled. The non-refundable fees listed above are not included in the calculation. All school accounts must be paid in full before school records or grades will be released.

We agree to pay the tuition according to arrangements outlined above and in the Parent/Student Handbook. We also understand that any monthly payment not made by the 15th of the month will result in a \$25.00 late fee being accessed.
